Mewn cyfarfod o'r Grŵp Tasg Iaith ar 22 Mai 2012 fe gyflwynwyd Adroddiad Monitro drafft y Cyngor i Gomisiynydd y Gymraeg ar gyfer 2011/12.

The Council's draft Monitoring Report to the Welsh Language Commissioner for 2011/12 was presented to the Language Task Group on 22 May 2012.

Cyfeiriwyd at y risg a nodwyd yn yr adroddiad o ran capasiti'r Uned Gyfieithu o ganlyniad i gollu un swydd amser llawn fel rhan o arbedion effeithlonrwydd 2011/12. Roedd y Grŵp o'r farn bod angen monitro'r sefyllfa'n ofalus, yn arbennig yn wyneb bwriad Comisiynydd y Gymraeg i gyflwyno dyletswydd ar gyrf cyhoeddus i gydymffurfio â Safonau statudol newydd sy'n ymwneud â'r Gymraeg.

Reference was made to the risk noted in the report with regard to capacity in the Translation Unit due to the loss of one full-time post as part of the 2011/12 efficiency savings. The Group was of the opinion that the situation needed to be monitored carefully, particularly in view of the Welsh Language Commissioner's intention to introduce duties on public bodies to comply with new statutory Standards relating to the Welsh Language.


