2 DECLARATION OF INTEREST

3 MINUTES OF MEETING

The minutes of the meeting held on 20 September, 2017 were confirmed.

	<ul style="list-style-type: none"> • There is a reasonable expectation of confidentiality by the applicants that their application forms, assessments and interviews will be conducted in private. A breach of such a reasonable expectation of confidence is potentially actionable. • Publication of applications, and a wholly public selection process, might reasonably be expected to result in fewer, or no, candidates applying for future vacancies. • The Panel has been appointed to undertake the assurance role on behalf of the Council and the public and, following due process, will make its recommendation to full Council which will ratify the final appointment. • The final appointment will be made public. • Much of the process is already in the public domain and more detailed information about the process would likely be published in the event of a Freedom of Information Act 2000 request.
