### **Constituency Activity**

Having counted the number of enquiries in my records book. I see that I have dealt with approximately 100 requests for assistance or information of various kinds. These fall under the following headings –

Housing – elected members are not involved in the housing allocation process but are able to represent prospective tenants in discussions on the number of points awarded to their applications if the prospective tenant has given permission for them to do so. In this area I have helped to ensure that prospective tenants have the correct number of points and I have made enquiries on behalf of tenants with regard to renovation work.

Highways – requests to repair potholes, walls, cut roadside verges, signs, speeding, street lighting and safety issues in Benllech Square.

Public Footpaths – requests to maintain paths.

Waste – assisting in securing replacement bins.

Planning – enquiries with regard to policy, enquiries with regard to progress made by the department in dealing with planning applications, complaints from residents who are unhappy with decisions, requests for me to speak as a local member on planning applications.

I attend Llanfairmathafarneithaf Community Council as a member and Pentraeth Community Council as a County Councillor.

I am Chair of the Ysgol Goronwy Owen Board of Governors. The school was recently inspected by Estyn and I am a member of the Ysgol Sir Thomas Jones Board of Governors.

#### **Initiatives & Special Activities**

I have worked with a community group and the Age Friendly Communities project to establish allotments in Benllech.

As Portfolio Holder for Education I have been involved in strategic education matters including driving the education modernisation agenda politically within the County.

Representing the County Council as Political Leader in a number of events, activities and meetings during the year – the Royal Welsh Show in Builth Wells, the Anglesey Show, North Wales Leaders Meetings, meetings of the Welsh Local Government Association.
